Austria's Federal Ministry for Economic Affairs announced plans to launch a new funding round on June 23, , offering up to 20% "Made in Europe" bonuses for small-scale solar photovoltaic (PV) and energy storage projects using European-manufactured components. The government had budgeted EUR12 million (\$14 million) for a second funding round but wants to finance successful applications and bring 220 MW new solar and 200 MWh of storage online.
