How does federal funding for electric vehicle infrastructure work? Federal funding for electric vehicle infrastructure can be drawn from several sources, including competitive and formula grant programs, loan financing programs, and tax incentives. The below table provides an overview of these funding types.

Types of Federal funding and financing programs. Can I get a tax credit for EV charging equipment? If you purchase EV charging equipment for a business, fleet, or tax-exempt entity you may be eligible for a tax credit. Starting on Jan. 1, , the value of this credit is 6% of the cost of property subject to depreciation, with a maximum credit of \$100,000 for each single item of property.

Do electric vehicles qualify for a tax credit? This major legislation will affect individuals, businesses, tax exempt and government entities by providing tax credits and deductions. Determine whether your purchase of an electric vehicle (EV) or fuel cell vehicle (FCV) qualifies for a tax credit. EV charging infrastructure is an eligible expense under several HUD grant programs. Potential applicants should confirm eligibility with the designated program office and agency contact. In addition, some HUD programs incentivize the adoption of energy efficiency and other sustainability measures, which may include EV charger installation.

Are EV charging stations tax deductible? If you purchase EV charging equipment for your principal residence, you may be eligible for a tax credit for the charging station. This credit is 30% of the cost of 1) the EV charging port, 2) components and parts that are essential to the operation of the charging port, and 3) labor for constructing and installing the charger, up to \$1,000.

Can you get a clean vehicle tax credit if you buy a EV? Starting Jan. 1, , if you purchase a new or pre-owned EV, you may be able to effectively lower the vehicle's purchase price by transferring the clean vehicle tax credit to a registered dealer. This credit can be claimed at the time of sale at over 9,500 registered dealers rather than waiting to claim the credit on next year's tax return.
