Why should you write a policy brief? Writing a policy brief evidences outreach and displays awareness of the impact of research, an increasingly necessary stage in securing grant funding. Most importantly, writing a policy brief can help change policy for the better! HOW effective are they? Policy actors are busy and do not have time to read full length academic papers. Where can I find an example of a policy engagement brief? For some examples which follow a similar structure, look at the University of Bath's Institute for Policy Research or Durham University Law School's Policy Engagement site (although be aware these are generally social science briefs). What is the difference between a research paper and a policy brief? It will relate the findings to current policy debates, with an emphasis on applying the research outcomes rather than assessing the research procedures. A research paper might also suggest practical actions, but a policy brief is likely to emphasize them more strongly and develop them more fully. What is a policy brief? Policy briefs are usually created for a more general reader or policy maker who has a stake in the issue that you're discussing. Many academic disciplines discourage using unnecessary jargon, but clear language is especially important in policy briefs. Why do policy briefs need to be condensed? Condensing findings into policy briefs reduces the potential for important research to be lost because the research is in a format that policy actors do not have time to access. Policy briefs have the potential to reach large audiences through different networks because of their condensed format. How do you write a policy brief? A policy brief should have a clear and specific purpose, supported by the evidence. It is best to concentrate on just one issue or argument. Considering the evidence: Is there a specific action you would like this audience to take? Is there something new and important you would like them to know? What do you want them to do with your findings? The brief is usually at the very top of the first page, and it is recommended that it is written as the final step. It usually includes convincing statements about: the specific problem under consideration, the most striking shortcomings of public policy, the main recommendation. Most policy papers are written in the form of a white paper, which offer authoritative perspective on or solutions to a problem. White papers are common not only to policy and politics, but also in business and technical fields. In commercial use, white papers are often used as a marketing or sales.
