Are there changes to the VAT treatment of grant-funded heating equipment? There have been no changes to the VAT treatment of supplies of grant-funded installations of heating equipment, currently applied at the reduced rate of VAT (5%) which is covered in section 3 of this notice. Do I need to read a vat notice? You should read this notice if you're a contractor or subcontractor installing: Section 30 of the VAT Act, provides that goods and services specified in schedule 8 to the Act are zero-rated. Group 23 of schedule 8 specifies when installations of energy-saving materials are zero-rated. What information should I include in a vat notice? You'll need to include the full title of this notice. Do not include any personal or financial information like your VAT number.
